## CONFIDENTIALITY OF YOUR PRIVATE COMMUNICATIONS

PRIVACY REGARDING WHAT KGRUPPE PRODUCTS AND SERVICES YOU USE Our system automatically gathers information about areas you visit on our service. We do not share any of this data with entities outside of our company. We do use navigational information to understand how our subscribers as a group use Kgruppe products and services so that we can make Kgruppe better.

PRIVACY REGARDING YOUR PERSONAL CONTACT INFORMATION When you join Kgruppe, we ask you for your name, address, and billing information - including the PayPal account used to pay for your Kgruppe account obligations. Here is how we protect that information:

- 1. Kgruppe will not give out your telephone number or screen names (e-mail addresses), except where needed to deliver a product or service you ordered.
- 2. Kgruppe will not give out your account information unless you authorize it.
- 3. Kgruppe will not give out information that would link your screen name with your actual name.

### REQUEST REMOVAL OF YOUR DATA
